- 3) The student's company must have been in business for at least the last six consecutive months by November 2015, and the business must be a for-profit business.
- 4) The student must have not been the GSEA winner in the past and/or were not one of the five finalists for the previous year's GSEA Global Finals competition.
- 5) The student's company is not required to have been generating profit
- 6) Registration of the student's company in SEC or DTI is required by the time of regional and global final events
